Deal registration (90-day protection)

- **Eligible:** net-new account, named org + buyer/contact, active decision timeline.
- **Window:** 90 days from approval.
- **Conflicts:** first approved registration wins; existing pipeline excluded.
- **Routing:** buyers use Procurement lane; partners use Partner lane (RID continuity).

What Noetfield delivers

Time-boxed Copilot readiness assessments. Outputs are decision artefacts with traceable evidence. Minimum-access by default; no confidential data in public intake.

Partner standards (non-negotiables)

- Public = non-confidential (no secrets, credentials, customer data, regulated personal data).
- Named artefacts and evidence IDs for material claims (export/screenshot/policy/log).
- Escalate blockers fast (privacy, security, procurement).

Partner value + enablement

- Procurement-safe routing; reduces friction in Copilot decisions.
- Board-ready outputs that protect partner credibility.
- Enablement: co-sell emails + routing links; response targets (ACK 1bd; blockers 2bd).
